

Mad River Township Trustees met in regular session Monday February 18, 2014. Trustees McClure, Estep, Catanzaro were present. Fiscal Officer Leonard also present. Trustee Estep called the meeting to order at 7:40 pm. The meeting opened with the Pledge of Allegiance.

Trustee Catanzaro motioned to dispense with the reading of the minutes, seconded by Trustee McClure, all trustees voting yes. Trustee McClure motioned to approve the minutes, seconded by Trustee Catanzaro, all trustees voting yes.

#### Reports:

Enon Fire and EMS Chief Tracy Young – Chief Young went over the run stats for the month. They had a joint ice rescue training with WBFD at Speedway Feb 9<sup>th</sup>. They are currently doing protocol training updates. Progressive Printers out of Dayton a big thank you for printing our protocol training at no cost.

Trustee Estep thanked Tracy for attending the OTA Conf. in Cols.

Chief Kaufmann had a training and reported she would not be here.

Chief Bill Young – not present

Don O'Connor – the road dept has been incredibly busy. We currently have 40 tons of salt on hand. Salt is available on an as needed basis. A discussion ensued on the salt issue.

The 350 is in the shop again. The brakes are out. They are getting ready to cold patch some pot holes. The catch basins look good.

Last week was pretty busy in the cemetery. Don asked if there was a county ordinance or anything as the school kids have to walk in the road due to the sidewalks not being cleared.

Deputy Wise – The incident that Don was referring to in Holiday Valley and Green Meadows was that he was out tagging vehicles for 48 hour tow. 4 of the 50 cars still have not been moved. The Township has the authority to make an resolution for emergency snow removal. Jeff has copies of ORC 505.17.

He will be attending the Cub Scouts Blue and Gold Banquet on March 1.

A discussion ensued regarding the parking of vehicles in the plats where the plows cannot get through.

Trustee Catanzaro will work with Jeff to write the verbiage for a resolution for snow emergency for next fall.

A discussion ensued on the Property at Collier and Shank in regards to junk vehicles. Jeff will meet with the property owner and make contact.

Fiscal Officer Leonard – Passed out reports to the Trustees and Dept. heads present. Appropriations have been input, Purchase Orders have been certified. 2013 Road Mileage Certification needs signed and submitted.

#### Old Business:

Trustee McClure attended the TCC Meeting and the issue of the sound wall was brought up. The meeting consensus said that a new study would not change the end result. The issue is the sound quality and the number of people affected. Some issues were clarified at the meeting.
